

INDEPENDENT LIMITED ASSURANCE STATEMENT

To: The Stakeholders of AstraZeneca Plc

Introduction and objectives of work

Bureau Veritas UK Limited ('Bureau Veritas') has been engaged by AstraZeneca Plc ('AstraZeneca') to provide limited assurance over sustainability data reported in its Sustainability Data Summary 2019. This Assurance Statement applies to the related information included within the scope of work described below.

Selected information

The scope of our work was limited to assurance over all the performance data and information included in the AstraZeneca's Sustainability Data Summary 2019 ('the Report') for the period 1st of January to the 31st of December 2019 (the 'Selected Information'). This included:

- Access to Healthcare Targets and Progress
- Environmental Protection Targets and Progress
- Ethics and Transparency Targets and Progress

Reporting Criteria

The Selected Information has been prepared in accordance with internal definitions set by AstraZeneca in their sustainability strategy to track and monitor their progress. The definitions for AstraZeneca's GHG reporting are aligned with the Greenhouse Gas Protocol Corporate Accounting and Reporting Standard (revised edition).

Limitations and Exclusions

Excluded from the scope of our work is verification of any information relating to:

- Activities outside the defined verification period;
- Positional statements (expressions of opinion, belief, aim or future intention by AstraZeneca) and statements of future commitment;
- Any other information included in the Report other than scope defined above.

This limited assurance engagement relies on a risk based selected sample of the selected information and the associated limitations that this entails. This independent statement should not be relied upon to detect all errors, omissions or misstatements that may exist.

Responsibilities

The preparation and presentation of the Selected Information in the Report is the sole responsibility of the management of AstraZeneca.

Bureau Veritas was not involved in the drafting of the Report. Our responsibilities were to:

• Obtain limited assurance about whether the Selected Information has been appropriately and accurately prepared;

- Form an independent conclusion based on the assurance procedures performed and evidence obtained; and
- Report our conclusions to the management of AstraZeneca.

Assessment Standard

We performed our work to a limited level of assurance in accordance with International Standard on Assurance Engagements (ISAE) 3000 (Revised), Assurance Engagements Other than Audits or Reviews of Historical Financial Information, and in accordance with the main requirements of ISO 14064:2006 Part 3 - Specification with Guidance for the Validation and Verification of Greenhouse Gas Assertions.

Summary of work performed

As part of its independent verification, Bureau Veritas undertook the following activities:

- 1. Assessed the appropriateness and accuracy of the Selected Information;
- 2. Conducted interviews with relevant personnel of AstraZeneca;
- 3. Carried out four site visits, selected employing a risk-based approach, in the following sites: Macclesfield UK, Gaithersburg US, Gothenburg Sweden and Wuxi -China;
- 4. Reviewed the data collection and consolidation processes used to compile the Selected Information, including assessing assumptions made, the data scope and reporting boundaries;
- 5. Reviewed documentary evidence provided by AstraZeneca;
- 6. Re-performed a selection of aggregation calculations of the Selected Information;
- 7. Agreed a selection of the Selected Information to the corresponding source documentation.

Conclusion

On the basis of our methodology and the activities described above, nothing has come to our attention to indicate that the Selected Information has not been properly prepared, in all material respects.
